Notes

1	The Waka Kotahi allocated 'Approved Provider Number' must be notated on the top left corner of the translation.
2	Each translation issued must have a unique reference number. This unique number will be assigned by the Approved provider. The purpose of this number is to assist in the audit process.
3	Specify if the document is an original licence or an original certificate issued by the overseas licensing authority confirming details of the driver licence. If the document is not an original (eg a photocopy, a scanned copy or a facsimile) then this must be stated on the translation.
4	This is the date licence holder first obtained their driver licence.
5	This is the date of issue of the actual licence card being translated. This date may or may not be the same as the date referred to in Note #4.
6	Licence classes held need to be fully translated.
7	Where the individual named does not fit the denominations for 'surname, first name, and middle name' because of cultural naming traditions, it should not be necessary to amend the field names on the template. Refer to note #9.
8	If the names on the licence are not separated into 'surname, first name, middle name, they should be entered into the relevant fields – eg all in the surname field (if all on one line) or in the surname/first name fields if displayed that way.
9	The above examples do not provide an exhaustive list of details that may be recorded on a licence. Any other relevant licence details should also be provided on the translation.
10	Include any other explanatory details that may be relevant eg explanation of difference in spelling of surname between passport and driver licence; or where there may be an additional name on the passport or driver licence; or where the named individual does not fit the name denominations for 'surname, first name, and middle name' due to cultural naming traditions (patronymic Russian surnames).
11	The translator's name must be provided. This may be the person who processed the translation, alternatively it may be another person authorised to sign on behalf of the provider eg an Editor or Chief Translator.
12	The translator's signature must be provided. This is the signature of the person referred to in note #10.



13	Where a translation is undertaken by a sub-contracted translator the Approved Provider must provide the name and signature of its own staff translator, or editor duly authorised to certify the translation as being a true and accurate translation of the Document issued by the overseas licensing authority confirming the details of the driver licence.
14	If any information (eg the description of licence classes) is obtained from a source other than the licence itself, then the source must be specified.
15	If any information is not provided (eg place of birth) then a '-' should be recorded. It is important that no sections are left blank.
16	All dates on the Translation must refer to the Gregorian calendar. If any dates have been converted from another calendar, then this must be stated in the additional comments field eg "licence dates have been converted from the Ethiopian calendar".
17	A copy of the document provided by the licence holder for translation must be attached to the back of the completed English translation. The completed English translation document and accompanying licence copy can be provided to the customer in either physical or electronic PDF format using the template provided. The customer is to be informed that the approved English translation documents must be presented to the Driver Licensing Agent as physical documents; either the original physical documents or, where the original is an electronic version, as good quality colour printouts.
18	If the document being translated has had any alteration, amendment, addition, or erasure, then this must be stated on the translation.
